**1 THE RESEARCH PAPER AND THE EXTENDED ABSTRACT**

**1.1** This public notice is available on the website of FUMEC, through the following link::

**1.2** The research paper must be unpublished.

**1.3** The research paper must obey the ABNT norms, in the requirements mentioned below:

**1.3.1** The file in Microsoft Word format may be in Portuguese or English and have a minimum of 15 and a maximum of 20 pages on A4 paper size, vertical position.

**1.3.2** Font "Times New Roman"; size 12; justified alignment; without separation of syllables; 1.5 line spacing; paragraph of 1.5 cm; margin - top and left: 3 cm, bottom and right: 2 cm.

**1.3.3** Citations (NBR 10520/2002) and references (NBR 6023/2018) must obey ABNT rules.

**1.3.4** The system for direct or indirect references citations must be in the author-date format (NBR 10520/2002), and the footnotes should be only explanatory.

**1.3.5** The abstract must be in accordance with the ABNT rules (NBR 6028/2003).

**1.3.6** According to NBR 6024/2012, the titles of all sections, from primary to fifth, should be aligned to the left, contain related text to them and be numbered progressively, and the numbering should start in the Introduction and end at final considerations.

**1.4** The Extended Abstract

**1.4.1** The extended abstract must be unpublished.

**1.4.2** The extended abstract must follow the ABNT norms, in the requirements mentioned below:





**1.4.2.1** The file in Microsoft Word format may be in Portuguese or English and have at least 05 (five) and a maximum of 10 (ten) pages on A4 paper size, in vertical position.

**1.4.2.2** Font "Times New Roman"; size 12; justified alignment; no syllables separation; 1.5 line spacing; 1.5 cm paragraph; margin - top and left: 3 cm, bottom and right: 2 cm.

**1.4.2.3** Citations (NBR 10520/2002) and references (NBR 6023/2018) must obey ABNT rules.

**1.4.2.4** The system for direct or indirect citations must be in the author-date format (NBR 10520/2002), and the footnotes should be only explanatory.

**1.4.2.5** The abstract must be in accordance with the ABNT rules (NBR 6028/2003).

**1.4.2.6** According to NBR 6024/2012, the titles of all sections, from primary to fifth, should be aligned to the left, contain text related to them and be numbered progressively, and the numbering should start in the Introduction and end at final considerations.

## **2. THE AUTHORSHIP**

**2.1** The extended abstract/ research paper shall be admitted with a maximum of 03 (three) authors.

**2.2** In cases of double or triple authorship, all authors must meet all the requirements described in this public notice, and there will be no differentiation between them.

**2.3** Extended abstract/ research paper may be submitted by: doctors, doctoral students, master`s, master`s students, specialists, specialization students, undergraduates or undergraduates students these last ones must obey item 2.4.

**2.4** Undergraduate, undergraduates students and specialization students will be accepted as authors of extended abstract/research paper submit with doctors, doctoral students, master`s, master`s students, these last one must submit the work.

**2.4.1** The extended abstract/ research paper with undergraduate, undergraduates students and specialization students authors must be orally present by the doctors, doctoral students, master`s, master`s students.

**2.4.2** Undergraduate, undergraduates students and specialization students should realize a brief personal presentation.





**2.5** It is the responsibility of the author to present proof of their title if requested during the event.

**2.6** The submission of extended abstract/research paper is allowed to authors from any areas of knowledge, considering item 2.4.1.

**2.7** The author who submits the extended abstract/ research paper is solely **responsible** for including the names of the other authors and their qualifications, as well as the definition of the order of presentation of the names.

**2.8** After submission of the extended abstract/research paper will not be accepted author inclusions, change in the order of names or even inclusion or corrections of qualifications.

### 3. THE SUBMISSION

**3.1** The extended abstract/research paper will be received **from July 9<sup>th</sup> to July 26<sup>th</sup> of 2021**, through the e-mails: (resumoppdgmec@fumec.br and [artigoppdgmec@fumec.br](mailto:artigoppdgmec@fumec.br)) precisely until 11:59 pm (Brasilia time).

**3.2** Each author may submit a maximum of 03 (three) extended abstracts/research papers for presentation at the event.

**3.2.1** Submission of up to two (2) extended abstracts/research papers to the same Research Group and a third one to another one will be allowed, as long as it is on a different day, according on the schedule of the event that will be made available on the <https://www.even3.com.br/ivcippdgmec/> registration [platform](#).

**3.2.2** To submit extended abstract/research paper it is necessary to forward them in the respective emails ([resumoppdgmec@fumec.br](mailto:resumoppdgmec@fumec.br) and [artigoppdgmec@fumec.br](mailto:artigoppdgmec@fumec.br)) in two versions: the first one in a Microsoft Word file with identification of the authors and remission in a footnote referring to their scientific qualifications whit their titles and institutional affiliations; the second version without identification, in a pdf file.

**3.3** The extended abstracts/research paper should be submitted exclusively through the instructions indicated in item 3.1, strictly following the specifications of this public notice and the procedures provided for in the platform of the event.

**3.4** The submission process through the indicated emails will take place in stages, according to the description below:

#### 3.4.1. FIRST STEP (addressing and electronic destination of the works):

**3.4.1.1** The author responsible for the submission must forward the extended abstract/research paper in the attached in the respective e-mail, observing the period





determined in item 3.1, indicating in the subject of the e-mail the research line / research group linked to Appendix II and III of this public notice.

**3.4.2.2.** If the extended abstract/research paper has 02 (two) or 03 (three) authors, the one responsible for the submission must inform the qualification data of the coauthors, according to item 2.7, in the file in Microsoft Word format.

### 3.5 SECOND STEP (sending the file in Microsoft Word format and pdf)

**3.5.1** The file in **Microsoft Word format** must contain the information in the extended abstract/research paper from its introduction, mentioning objectives, method, research development, conclusions, and references.

**3.5.2** The file in **pdf format** with the development of the extended abstract/research paper **MAY NOT HAVE** the names of the authors that can only appear when they are cited in order to ensure the unnamed analysis and impartiality of the evaluation.

**3.5.3** The **Microsoft Word format** file must contain the same requirements as the previous item (3.5.1) plus the identification of the authors.

**3.6** After submission of the extended abstract/research paper will not be permitted replacement, correction or alteration of the content of any kind.

**3.7** Each author is responsible for observing the menus in Appendix III, in order to correctly link them extended abstract/research paper to the equivalent line of research.

**3.8** The extended abstract/research paper submitted will undergo editorial review. Those which do not meet the rules of this public notice will have their extended abstract/research paper returned, so that the necessary adjustments are made by their respective authors.

**3.9** Authors who have their extended abstract/research paper returned, according to the previous item, will have up to 72 hours to make the necessary adjustments, otherwise they will be disqualified.

## 4. THE EVALUATION AND DISSEMINATION OF RESULTS

**4.1** All extended abstracts/research papers submitted will be evaluated by a special committee designated by FUMEC University.

**4.2** The evaluations will be carried out through the double blind review method, which allows the unnamed analysis of extended abstract/research paper, ensuring the impartiality of the evaluation. The method also requires the examination of the abstract extended/research paper by at least two evaluators, which guarantees the reduction of subjectivity and ideological preferences.

**4.3** The list of **extended abstracts/research papers approved for presentation at the 4<sup>th</sup>**





**International Congress of Graduate Level of FUMEC: Dialogues between Public and Private Law in the innovations of the 21<sup>st</sup> Century** will be published on the portal of FUMEC (<http://ppg.fumec.br/direito/iv-congresso-internacional/>) until August 6<sup>th</sup> of 2021.

**4.4** Authors whose extended abstract/research paper have been approved and selected, should consult in the above portal the result of the works approved for presentation at the event.

**4.5** Up to the 25 (twenty-five) best extended abstracts/research papers submitted to the Research Lines may be selected for presentation in each Research Group, among those that achieve an average grade of 7.0 (average of the grades assigned in the evaluation).

**4.5.1.** Those who, reaching an average of 7 (seven) will also be classified, regardless of the limit established in the previous item.

**4.5.2.** If certain lines of research have a large number of extended abstracts/research papers of high quality, proven by the evaluations, the organization can subdivide these groups; similarly, presentations of the research lines with low demand can be gathered in a single Research Group.

**4.6** The notes will be composed of an arithmetic mean of the items below and classified by criteria met between 0 (zero) and 10 (ten). The evaluators will review extended abstracts/research paper based on the following items:

**4.6.1** Does the title of the extended abstract/research paper correspond to the content developed?

**4.6.2** Was the extended abstract/research paper submitted to the correct search line?

**4.6.3** Does the abstract indicate objectives, method, results and contributions?

**4.6.4** Do the keywords properly identify the content of the extended abstract/research paper?

**4.6.5** Were the title, abstract and keywords correctly translated into the foreign language, which is different from the one adopted for the development work?

**4.6.6** Does the introduction present the appropriate delimitation of the subject, the objectives and justifications of the research and the method used?

**4.6.7** Is the theoretical framework used appropriate and coherent with the results obtained?

**4.6.8** Are the references current and do they cover relevant literature on the subject?

**4.6.9** Does the research performed have complexity and depth compatible with the requirements of Graduate Level studies?

**4.6.10** Are the structure and language of the extended abstracts/research papers clear and able to achieve the communication of the research results?

**4.6.11** Was the method used adequate to achieve the objectives proposed for the research?

**4.6.12** Is the conclusion coherent with the results presented in the development of the extended abstracts/research papers?

**4.6.13** Does the extended abstract/research paper have the form required by the norms of this public notice, according to the rules of ABNT?





4.7 No appeal will be granted on the final decision of the evaluation at any stage of the event.

## 5 THE INDICATION OF RESEARCH PAPERS/EXTENDED ABSTRACTS BY GRADUATE LEVEL PROGRAMS

5.1 Each Graduate Level Program in Law may indicate up to 02 (two) research papers and/or extended abstracts involving its researchers, students or teachers.

5.2 The nominations of research papers and/or abstracts extended for the **4<sup>th</sup> International Congress of Graduate Level of FUMEC: Dialogues between Public and Private Law in the innovations of the 21<sup>st</sup> Century** will be accepted between July 9<sup>th</sup> and July 26<sup>th</sup> of 2021, by programs that send an e-mail indicate below (item 5.5)

5.3 The extended abstracts/research papers indicated should represent the most relevant research of the Program, aiming at the recognition and increase of the quality of the research produced.

5.4 Only the research papers and/or extended abstracts submitted from July 9<sup>th</sup> to July 26<sup>th</sup> of 2021 according to item 3, may be nominated for the **4<sup>th</sup> International Congress of Graduate Level of FUMEC: Dialogues between Public and Private Law in the innovations of the 21<sup>st</sup> Century**, which respects all the rules of this public notice.

5.5 The indications should be sent exclusively to the emails: [resumoppdgfumec@fumec.br](mailto:resumoppdgfumec@fumec.br) and [artigoppdgfumec@fumec.br](mailto:artigoppdgfumec@fumec.br)

5.6 The indication of the research papers/extended abstracts must be done by the Program Coordinator through the official e-mail address of the Graduate Level, which will contain:

5.6.1 Name of the Graduate Level that is performing the indication;

5.6.2 Name of Graduate Level Coordinator;

5.6.3 Title of the indicated research paper/extended abstract and their respective authors.

5.7 The research paper/extended abstract should be approved in the editorial analysis, which will comply with the rules of this public notice.

5.8 After the editorial analysis, the research paper/extended abstract indicated by the Program will be automatically approved by the Organizing Committee, which will consider it representative of the Institution.

5.9 The publication of the research paper/extended abstract in the proceedings or journal will be conditioned to the its presentation in its respective Research Group.

## 6 THE PRESENTATION IN THE RESEARCH GROUPS

6.1 The extended abstracts/research papers may only be presented in their respective





Research Groups.

**6.2** Only authors will be able to present the extended abstract/research paper and will have 5 to 10 minutes to do it. This time will be established, in each Research Group according to criteria established by the Coordinators, in accordance with the number of works approved and the time available.

**6.2.1** It will be mandatory that the authors, during the presentation of their research paper/abstract extended in the Research Group, have their video cameras open to make possible to register their presence.

**6.2.2** Undergraduate authors, undergraduate and specialization students will participate in the presentation of their extended abstracts/research paper as provided for in item 2.4.2.

**6.3** In the case of extended abstract/research paper with more than one author, the presence of only one of them at the time of the presentation will be enough, observing item 2.4.2.

**6.4** The order of presentation of the extended abstracts/ research papers in the Research Groups, by their respective authors, will be defined at the discretion of the Coordinators at the beginning of the presentation of the work.

**6.5** The Coordinators of the Research Group will define how the work will be conducted, and there may be a debate following the presentations, at the end of blocks, or at the end of all the presentations.

**6.6** The presentations will be made exclusively orally, with the video camera open, not being allowed to present, on screen, images or texts.

**6.7** The days of the Research Groups will be subject to date changes, respecting the same days foreseen for the **4<sup>th</sup> International Congress of Graduate Level of FUMEC: Dialogues between Public and Private Law in innovations of 21<sup>st</sup> century**, according to Appendix I.

**6.8** Virtual presentations of extended abstracts/research papers will be through the Google Meet platform. All participants must provide the necessary procedures to access it.

**6.9** The Invitations/links to access the research groups will be made available on the portal of FUMEC (<http://ppg.fumec.br/direito/iv-congresso-internacional/>), and may eventually be sent through e-mail by August **9<sup>th</sup> of 2021**.

**6.10** In the case of extended abstract/research paper with more than one author, each one must participate in the event at their residence (or workplace, faculty, etc.), with their access and duly registration at the event, and should not be joined in one of the places for presentation.

## 7 THE PUBLICATIONS IN JOURNALS





7.1 From the research papers presented at the **4<sup>th</sup> International Congress of Graduate Level of FUMEC: Dialogues between Public and Private Law in the innovations of the 21<sup>st</sup> Century**, there will be a selection for publication in *Meritum* Journal, based on the following requirements:

- a) Indication of evaluators;
- b) Notes;
- c) Exogenous;
- d) Thematic relevance.

7.2 The list of research papers selected for publication for *Meritum* Journal will be published on the portal of FUMEC (<http://ppg.fumec.br/direito/iv-congresso-internacional/>) and, eventually, followed by an e-mail address to the authors of the selected ones, according to a list extracted from the works presented at the event.

7.3 The authors of the research papers selected for publication in the journal indicated above, must resubmit their works to *Meritum* Journal, according to the guidelines and editorial criteria of the platform.

7.4 The submission of the selected research paper must strictly follow the norms of the journal, under penalty of not being published if they do not meet the requirements described in the public notice.

7.5 The deadlines for the publication of the selected research papers will follow the guidelines and the calendar of *Meritum* Journal.

7.6 The research paper published in the journal will not be published in the events annals of the event of **4<sup>th</sup> International Congress of Graduate Level of FUMEC: Dialogues between Public and Private Law in the innovations of the 21<sup>st</sup> Century**.

## 8 THE COPYRIGHT, PUBLICATIONS, DECLARATIONS AND CERTIFICATES

8.1 The authors, when submitting their research papers/extended abstracts, automatically attribute the copyrights in an exclusive, irrevocable and free of charge way to FUMEC, not consisting in any remuneration to the authors. The FUMEC Institution will publish the extended abstracts/research papers, provided that with reference to the respective authors, in digital or printed format, in their annals of the event.

8.1.1 The extended abstracts/research papers published by FUMEC may not be published by the authors by any means (printed or digital) without the institution's agreement, which has exclusive publication rights.

8.1.2 The publications of extended abstracts/research papers will only be authorized after official publication by FUMEC and conditioned to the inclusion of a note indicating







the original publication.

**8.2** The extended abstracts/research papers presented at the event will be published as annals of the event, with ISBN issued by the Brazilian Book Chamber, until November 22<sup>nd</sup> of 2021, and may be extended until January 20<sup>th</sup> of 2022.

**8.3** Only the author, registered as one of research paper or extended abstract modality, having presented their work in their respective Research Group, will have their declaration of presentation available.

**8.3.1** The research paper/extended abstract presenter declaration will not serve to record the frequency in the event. Therefore, the authors should observe the items 8.8, 8.9 and 8.10.

**8.4** The publication of the research papers/extended abstracts, whether in the annals of the event or periodical, will be subject, obligingly, to its presentation, in the respective research group, by one of the authors, observed item 2.4.2.

**8.5** All declarations and certificates related to the **4<sup>th</sup> International Congress of Graduate Level of FUMEC: Dialogues between Public and Private Law in the innovations in 21<sup>st</sup> Century** will be made available until August 20<sup>th</sup> of 2021 through e-mail. The FUMEC Institution is not responsible for incorrect or incomplete registration.

**8.6** All authors of extended abstracts/research papers will have the right to certificate of participation in the event, with the respective workload, conditioned to attendance. The listeners will be required minimum frequency for certification.

**8.7** The attendance will be measured by digital recording through the platform where the respective activity will be transmitted.

**8.8** The times for performing the frequency records will be randomly defined, with a tolerance of 30 minutes delay after the effective beginning of the activity.

**8.9** Two digital attendance lists will be issued by the platform at two different times. To be considered the presence, the participant must be present in at least one of the two lists.

**8.10** It will be the responsibility of the participants to maintain their internet connection stably in order to at the time of automatic registration their presence is effective.

## 9 THE REGISTRATION

**9.1** To presentation of extended abstract/research paper the registration must be mandatorily as "author of research paper/ extended abstract" in the research group for which it is approved, effected by the even platform through the link: <https://www.event3.com.br/ivcippgdfumec/>

**Single paragraph:** Registration for the other activities of the event, Panels, Forums





Workshops and Lectures that do not include that Research Group in which the author will present their research paper/extended abstract must be held separately and are the full responsibility of the interested party.

**9.2** Registration for the event is individual, in other words, each registrant who is participating in the event must register in the period from August 6<sup>th</sup> to August 9<sup>th</sup> of 2021.

**9.3** Any person can participate in the event as a listener, according to item 9.5.3. In this case, they will receive only the certificate of participation corresponding to the activity they integrate, as described in item 8.7.

**9.3.1** The listeners will receive a Certificate of Participation corresponding to the respective workload of the activity they participate in: panels, workshops, research groups or opening lecture.

**9.3.2** The listeners will have access to all activities, subject to individualized registration for each research group or lecture that is interested in participating through link (<https://www.even3.com.br/ivcippgdfumec/>). The invitation/link to access the activities will be available on the portal of FUMEC until August 9<sup>th</sup> of 2021.

## **9.5 REGISTRATION MODALITIES:**

### **9.5.1 AUTHOR OF EXTENDED ABSTRACT/RESEARCH PAPER**

Modality that will allow the presentation and publication of extended abstract / research paper, poster presentation and participation in panels, forums, workshops and lecture, conditioned the individualized registration.

### **9.5.2 AUTHOR POSTER**

Modality that will allow presentation and publication of posters and participation in panels, forums, workshops and lectures, conditioned the individualized registration.

### **9.5.3 LISTENERS**

Modality that will allow participation in panels, forums, workshops, working groups and lectures, conditioned the individualized registration.

## **10 THE COORDINATION OF RESEARCH GROUPS**

**10.1** Each Research Group will have at least 03 (three) coordinators, one of which must be a member of the Graduate Level of FUMEC, and the others may be invited professor.

**10.2** The Coordinators of the Research Group will have autonomy to define the order and time of presentation of the extended abstracts/research paper, respecting the time equally distributed among the authors for the presentation and reserving time for debates and comments.

**10.3** The Coordinators should write the presentation text of their Research Group for its publication.





**10.3.1** The Coordinators must write and register on the platform of FUMEC their respective texts of presentation of the works until August 31<sup>st</sup> of 2021.

**10.4** The Coordinators of the Research Group will receive a declaration.

**10.4.1** Research Group Coordination declaration will only be made available after item 10.3.1 has been fulfilled.

**10.5** The Coordinators, with their assistants of the coordination of the work, must ensure that the presentations of the extended abstracts/research papers will occur without the authors being interruption.

**10.5.1** The Research Group coordinators will define when the discussions will take place. It may be after blocks of presentations or at the end of each extended abstract/research paper presented.

**10.5.2** Considering that the extended abstracts/research paper submitted to the Research Groups will be previously evaluated by the double blind review method, the coordinators are expressly forbidden to make any kind of new evaluations of them, being responsible only for coordinating the debates between presenters and the audience.

**10.5.3** They may be assistants of the coordinators of the Research Group, master or master's students of Graduate Level of FUMEC, defined, preferably, among the collaborators of the realization **4<sup>th</sup> International Congress of Graduate Level of FUMEC: dialogues between Public and Private Law in the innovations of the 21<sup>st</sup> century.**

**10.6** Once the above criteria are met, the following items will be used as the selection classification requirements of the coordinators:

**10.6.1** Recognized contribution to research in the area of the respective Research Group;

**10.6.2** Preferably have extended abstract/research paper selected to be presented in the same Group in which you will coordinate;

**10.6.3** Preferably not having an extended abstract/research paper to be presented in another Research Group that occurs on the same day and time as the one they will coordinate.

## **11 THE SPECIFICS OF THE VIRTUAL MEETING**

**11.1** It will be the responsibility of the participants to ensure the necessary conditions and conduct to participate in an event broadcast live over an internet connection, observing the following aspects:

**11.1.1** The participants must be exclusively available for the activity to which they will participate, as such as, a Research Group, lecture, panel, workshop or forum;





**11.1.2** The participants must have the necessary equipment (audio and camera) to participate in the Research Groups;

**11.1.3** The participants must have high quality and stability internet connection to ensure their participation without interruptions;

**11.1.4** The participants must in an appropriate physical space, respecting the good conduct with regard to clothing and silence in the environment where it is in order not to have interruptions during the presentations;

**11.1.5** The participants must read all the guidelines and information about procedures, programming and technical details contained on the official website of the event.

## 12 THE FINAL PROVISIONS AND PRIVACY AND PROTECTION OF PERSONAL DATA

**12.1** If the research paper/extended abstracts submitted will be excluded from the publication before, during or after the event, without any type of certificate or declaration being issued.

**12.2** The FUMEC institution will not be responsible for any technology failures arising from internet connections or data congestion caused by excessive number of simultaneous accesses in recent days valid for the submission of extended abstracts/research papers.

**12.3** The Board of Directors of FUMEC shall reserve the right to resolve the questions relating to any differences in interpretation or application, errors, redundancies or omissions of this public notice.

**12.4** The participants, when registering for the event, express their authorization and consent so that FUMEC University can collect and process the personal data provided at the time of registration and those present in the other documents provided.

**12.5** The consent covers the authorization for the data provided to be processed for the completion of registration at the event, as well as for the preparation of the profile of the registrant and making any contacts. There may also be sharing with others parties, authorized by FUMEC, exclusively for the purposes informed and in accordance with the privacy policies of FUMEC University and this public notice.
